Pension Application of John Simpson Aldridge W9698 Transcribed and annotated by C. Leon Harris

[John Aldridge's declarations are in his own handwriting.]

State of Ohio } SS Clermont County }

On this 4th day of October in the year 1819 before me the Subscriber, one of the associate judges of the court of common pleas for the county aforesaid personally appeared John Aldridge aged fifty eight years resident of Clermont county and State of Ohio who being by me first duly sworn, according to law doth on his oath make the following declaration, in order to obtain to obtain the provision made by the late act of Congress, entitled An act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war: That he the said John Aldridge enlisted first in the year 1776 for the term of five or six months and was in a battle near Fort Washington and the battle at White plains [28 Nov 1776] and was discharged in Philadelphia

And again enlisted in the year 1777 in the back woods of Virginia now the county of Green [sic: Greene] in the State of Pensylvania in a company commanded by captain James Woods of the 13th Reg't. commanded by Col [William] Russell of the Virginia line and continental establishment that he continued to serve in said corps or the service of the United for three years untill the year 1780 when he was discharged from service in Pittsburgh in Pensylvania from a company commanded by Capt. Uriah Springer of the 9th Virginia Reg't. [renumbered from 13th to 9th on 14 Sep 1778 while at Fort Pitt] commanded by Col John Gibson that he was in the battle of Brandywine [11 Sep 1777] and that he is in reduced circumstances and stands in need of assistane from his country for support [signed] John Aldridge

Commonwealth of Kentuckey Boon county [sic: Boone County KY]

This day came William Aldridge [pension application S12921] before me one of the Justices of the peace for s'd County and being duly sworn as the law directs Sayeth that John Aldridge inlisted in the flying camp and that he the said John Aldridge continued in the service during the term for which it was raised and that the said John Aldridge Entered into the service in seventeen hundred and seventy seven in James Woods Company for the space of three years and that the said John Aldridge continued in the service untill lawfully discharged this deponeth further sayeth not Sworn before Me this 18 day of Sept 1819 Thos Connely JPBC

State of Indiana } on this 11th day of July 1821 personally appeared in open court beeing the Circuit court within and for said county and also being a court of record which

have the power of fine and imprisonment John Aldridge aged sixty years resident in said county who first being duly sworn according to law doth on his oath declare that he served in the revolutionary war as follows (to wit) first in the thirteenth rigment in the virginia line commanded by col Russell and afterwards in the ninth rigment commanded by col John gibson in the virginia line and that he was notified of his being inscribed on the pension list roll of the agency at eight dollars pr month by a pension certificate No 15,074 bareing date the fourth day of November 1819. I solemnly swar that I was a resident citizean of the United States on the 18th day of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress entitled "an act to provide for certain person engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18th day of March 1818 and that I have not nor has any person in trust for me any property or securities contracts or debts due to me nor have I any income other than what is contained in the Schedule hereto

NOTES:

On 16 Oct 1832 in Campbell County KY John Aldridge deposed in support of William Aldridge's application for a pension [S12921].

On 24 July 1843 Mary Aldridge, 83, of Rush County Indiana, applied for a pension stating that she thought her late husband, John Aldridge, served in the Revolutionary War from the state of Maryland. She declared that she married John Aldridge in Maryland on 18 Nov 1783, and he died 17 Nov 1842. Her application was certified by son Nathan Aldridge. As evidence of her marriage she submitted a family record kept by her late husband in an old prayer book and transcribed below. On 12 Aug 1844 Nathan Adldridge and Erasmus Aldridge applied for the amount of pension due to Mary Aldridge up to 27 Nov 1843, when she died leaving the following children: Nathan Aldridge, Erasmus Aldridge, Delila Layton of Rush County, and Elizabeth Steers, wife of Rafe Steers of Clermont County. The following orphaned grandchildren also survived Mary Aldridge: children of John Aldridge deceased - Elizabeth Bosell, wife of Rice Boswell of Bartholomew County IN; Eliza Aldridge; Ruhama Aldridge; Darlington D. Aldridge; Joseph Franklin Aldridge; Isam Aldridge; Philander Aldridge; John S. Aldridge; Barr E. Aldridge of Rush County. Children of Son of Joseph Aldridge deceased - Henry Aldridge of Rush County. Children of Polly Smith deceased - Anna Smith and Mahala Smith of Clermont County. Children of Rachel Steers deceased – John Steers, Alfonso Steers, and Cyrus Steers of Rush County.
