[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

State of South Carolina Abbeville District: June 11th, 1845 Court of Ordinary

On this the eleventh day of June 1845, Personally appeared before the Court of Ordinary in the State of South Carolina Abbeville District, Nancy Brooks, widow of Elisha Brooks, a resident of the above named State and District aged Seventy-nine years the twenty-second of last September, who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed July 7th, 1838, entitled "an act granting half pay and pensions to certain widows." That she is the widow of Elisha Brooks who was as she believes and always understood, a volunteer in the South Carolina Infantry under Captain John Wallis [John Wallace] that he served two months as private and twelve months as Lieutenant in the State of South Carolina under Captain John Wallace as will appear from the evidence annexed. That she has no documentary evidence of her husband's Services in the war, or of her marriage with him. She further declares, that she was legally married to the said Elisha Brooks on the 12th day of January 1786 by Esquire Russell Wilson a resident and acting Magistrate of Edgefield District State of South Carolina; That her husband the aforesaid Elisha Brooks died on the 3<sup>rd</sup> day of November 1804. That she was not married to him prior to his leaving the service, but the marriage took place previous to the first of January 1794 (viz.) at the time above Stated.

Be it known, that on the 10th day of January A.D. 1852, before the subscriber, a Justice of the Peace in and for Abbeville District, personally appeared Nancy Brooks, and made oath according to law, that she is the only surviving child of James Butler -- Deceased, -- widow of Elisha Brooks -- (who was an officer of the War of the Revolution,) and a pensioner of the United States

at the rate of \$\_\_ per annum, that she has reason to believe that the said pension all to be increased; and that she is directly interested in the same, and makes this affidavit to be filed by her attorney, with any additional evidence or agreements that he may deem necessary in the prosecution of said claim.



"Explanation -- Elisha Brooks was the brother of Deponent's father, Z. S. Brooks & Mrs. Nancy Brooks is the sister of his deceased mother; the children of Elisha & Nancy Brooks therefore are before cousins of deponent -- John Wesley Brooks is only 8 days younger than Deponent, both being born in February 1790 -- and Matilda, Levina & Betsy Brooks children of Elisha & Nancy Brooks, are of ages, corresponding very nearly with the ages of his sisters as stated in the foregoing copy of the family record -- Hence he had reference to this record as a means of more certainly fixing the ages of his cousins, John W. Brooks, Matilda Brooks, Lavinia Brooks & Betsy Brooks, and forward no other purpose -- Given under my hand the \_\_ May 1846 at Edgefield.

John Wesley born February 13, 1790  
Matilda born in the fall of 1781  
Lavina born in the spring of 1793  
Betsy born about 1797 or 1798  
Stanmore B. date of birth not give  
William Butler, their youngest, born about 1800  
Veteran died November 3, 1804 in SC  
Behethland H. Butler, 81, as of January 1846, testified that Nancy Brooks was the sister of her husband, William Butler]

State of South Carolina Edgefield District: SS

Be it known that on this the 26<sup>th</sup> day of January 1846 before me Daniel Holland a magistrate in and for the District aforesaid personally appeared Behethland F. Butler a resident of said District & State aged Eighty One years the twenty-eighth day of December last past who being duly sworn saith that she became acquainted with Elisha Brooks when he was a young man, that she knew him during the war of the Revolution, that he served in the war of the Revolution in the South Carolina Militia: that the said Elisha Brooks (she remembers) was called a Lieutenant: – and although, being a female, she cannot say of her own knowledge that he was a Lieut. in the service, still she believes from the statements of those who had better means of knowing than herself, that he did hold that office in the war of the Revolution: That she was acquainted with Nancy Brooks, now of Abbeville District & State aforesaid wife of the said Elisha Brooks, about the year of our Lord 1782: that they were married about the year 1786, and that this deponent was present and witnessed the lawful marriage of the said Elisha & Nancy – the said Nancy being the sister of William Butler, the husband of this Deponent. That they had children Obadiah Brooks a son who died young: John Wesley Brooks their second child, a son: a daughter Matilda Brooks their third child: That John Wesley Brooks their second child was born on the 12<sup>th</sup> or 13<sup>th</sup> of February 1790. The deponent states this fact with confidence inasmuch as William Butler the fourth child of this deponent was born on the 1<sup>st</sup> day of February 1790; that Whitfield Brooks the 1<sup>st</sup> child of Z. S. Brooks & his wife Elizabeth, was born the 5<sup>th</sup> day of February 1790: Thophilus Hill the son of a neighbor and relative was born on the 10<sup>th</sup> day of February 1790 and John Wesley Brooks was born on the 12<sup>th</sup> or 13<sup>th</sup> day of February 1790. That the said Elisha and Nancy Brooks lived together as husband and wife until separated by death that the said Elisha Brooks died (deponent supposes from the ages of children and other circumstances) sometime after the year 1800 leaving the said Nancy his widow who remains still his widow.


Be it known that on this the 26th day of January in the year 1846 before me a magistrate

in and for said District personally appeared Zachariah Smith Brooks,<sup>1</sup> a resident of said District and State, aged 80 years in May last past, who being duly sworn, saith that he was a brother of Elisha Brooks, who was to his knowledge a Lieutenant and served in that capacity in the war of the revolution in the South Carolina Militia; and he is also acquainted with Nancy Brooks wife of the said Elisha Brooks now residing in Abbeville District and State aforesaid, which acquaintance commenced about the year of our Lord 1784 or 5 about at which time they were married and lived together as man & Wife until the death of said Elisha and had 8 children, the eldest a son by the name of John Wesley Brooks, the 2<sup>nd</sup> a daughter by the name of Matilda Brooks and the youngest, a son by the name of William Butler Brooks who was born about the year 1800. That his eldest child (one, a son died in infancy by the name of Obadiah) John Wesley Brooks was born in the year 1790, to wit on the 13th day of February 1790 & within 8 days of the birth of the first child of this Deponent. He states these facts from his own personal knowledge, the said Elisha being a brother of this Deponent & the said Nancy Brooks, his widow being the sister of Deponent's first wife & having lived within 10 or 12 miles from them up to the death of the said Elisha -- That the said Elisha & Nancy Brooks lived together as husband & Wife until separated by death, that the said Elisha died somewhere about the year 1809 but the precise time he is unable to state nor has he the means at present of ascertaining the exact date, leaving at his death the said Nancy, his widow, who remained still his widow & unmarried --

State of South Carolina Edgefield District

On the 27th Day of May 1845, Personally appeared in open Court Zachariah Smith Brooks, and after being duly sworn according to law, depose and saith, that he was in the war of the Revolution and that he was personally acquainted with Elisha Brooks, and that, the said Elisha Brooks served in the War of the Revolution -- 12 months as Lieutenant in the South Carolina Infantry under Captain John Wallis [Wallace], and 2 months as private, previous to being elected Lieutenant and this deponent further States, that the said Elisha Brooks served longer, but the time not recollected by him; neither the battles are recollected, And this deponent further States that the said Elisha Brooks was a volunteer in Edgefield District, South Carolina and was under the command of General Greene at the Siege of the old Ninety Six afterwards called Cambridge.
