Pension application of Daniel Isbell W9856 Transcribed by Will Graves Franks Tilly¹

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Missouri Macon County: SS

On this 21st day of September in the year 1844 before the on the Subscriber one of the Judges of the County Court in and for said County, personally appeared Franka Tilly a resident of said County aged seventy-six years who being first duly sworn according to law doth on her oath make the following Declaration in order to obtain the benefit of the Act of Congress passed July 7th 1838 and of the 22nd of August 1842 granting Pensions and half pay to certain widows. That she was married to Daniel Isbel on the 18th day of May in the year 1783. That her husband the aforesaid Daniel Isbel was a Fife Major for the Space of three years in the Virginia Continental or state troop, and which of said troops he served in she is not able to state – that she was not married to him till after the war of the Revolution. That she is not able to state the precise periods at which he left the service nor when he entered it or under what officers he served – but she has heard him say that his Captain was by the name of Isaah Moody [sic, Isaiah Moody?]. That she was married to the said Isbel by publication as she thinks in the County of Wilkes in the State of North Carolina at the time aforesaid, I the Reverend John Barlow –

That her husband the aforesaid Daniel Isbel died on the 4th day of May 1797. She was afterwards married to Ben. Tilly on the 20th day of March 1801 by license in Jessamine County Kentucky, and that the said Bennet Tilly [Bennett Tilly] died on the 15th day of March 1843. She further declares that she is still a widow and that she was not married to the said Daniel Isbel before he left the service of the United States but that she was married to him prior to the first of January 1794 viz. at the time above stated.

State of Kentucky Jessamine County Sct.

This day personally appeared before the undersigned one of the Commonwealth's Justices of the Peace in and for the County of Jasmine aforesaid Thomas Land a resident of said Aged sixty-two years, and being first duly sworn deposeth and saith. That he was well acquainted with Daniel Isbell who married Franky Land his father's sister. That he often heard said Isbell say that he was a soldier in the revolutionary war, from the state of Virginia, and also that he often heard

his father John Land say that said Daniel Isbell was a soldier in said war, being also a soldier in said war and well acquainted with said Isbell whilst he was in the service. That previous to the year 1794 said Daniel Isbell & his aunt Franky lived together as man & wife. That said Daniel Isbell was killed by one Thomas Lahorn in the year 1797. That his aunt Franky Isbell the widow of David Isbell deceased in March 1801 was married to Ben Tilley (the name he usually bore) at his father's house and he this deponent was at the marriage. He further states that he has often heard the said Ben Tilley say he served in the revolutionary war.

This affiant further gives as a reason why he recollects particularly the date of the marriage of Ben Tilly & his wife Franky Isbell, that he was attacked with the white swelling in one of his legs in the spring of the year 1801, and that spring whilst confined, having just arrived to the age of 18 years, he received his first notice to muster. And further this affiant saith not.

[pp: 25-26: On January 22nd, 1845 Hugh Chrisman of Jasmine County Kentucky gave testimony among other things that Daniel Isbell was killed in said County at the mouth of Hickman on the Kentucky River; that Franky Isbell was his widow; that Franky married Ben Tilley; on the same date and in the same County Samuel Hunter gave a substantially identical testimony to that given by Hugh Chrisman, adding that Daniel Isbell played the Fife well and that he always said that he played the Fife when he served in the revolutionary war.]
