[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indcipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of South Carolina Union District: To wit

On this 3rd day of October 1832 personally appeared in open Court before the Judge of the Court of Common Pleas and Sessions now sitting for the District aforesaid James Tracy Senr a resident in Union District aged Seventy-two years, who being first duly sworn in due form of law, doth on his oath, make the following Declaration in order to obtain the benefit of the Act of Congress passed June 7 1832 -- that he entered the service of the United States under the following named officers and served as herein stated. -- "I entered the service, in York District in the drafted militia, in Captain Jamison's [probably James Jamieson] Company, in Colonel Neil's [sic, Neel's, probably Andrew Neel's] Regiment, under command of General Sumpter [sic, Thomas Sumter] -- but cannot recollect the time, and marched from York to Orangeburg and continued in service in various positions until the Battle of the Hanging Rock [August 6, 1780], where General Sumter obtained the victory -- and some time afterwards fought in the engagement at Rocky Mount [July 30, 1780], under the same officers. -- I was then discharged and returned home. -- I again went into the service in Captain Jamison's [James Jamieson's] Company and fought at Blackstock's [November 20, 1780] where General Sumter was wounded -- And shortly after the engagement I enlisted for 10 months or during the war in the company commanded by Captain Jacob Barnett in Colonel Wade Hampton's Regiment; and during this service I was in the Battle of the Eutaw Springs [September 8, 1781] -- and continued in this service until we were finally disbanded at Orangeburg at the end of the War. My recollection is too much impaired to recollect any of the dates of my services -- and have no documentary evidence, and can only refer to Major Joseph McJunkin¹ to testify for me. -- I do hereby relinquish every claim whatever to a pension or annuity except the present and declare that my name is not on the pension Roll of the agency of any State except the State of South Carolina, which I also relinquish upon the condition that I obtained a pension from the United States -- I answer to the interrogatories put by the Court

I answer

1 & 2nd I was born on the 25th of September 1760 in the State of Maryland as I have been informed -- and have no record of my age.

3rd I lived in York District when I entered the service and have lived in the District of Union ever since the end of the War.


6. I never received and [sic, any] written discharge, but was always discharged by the verbal orders of my officers.

7. I refer to the Reverend Elias Mitchell and Major McJunkin to prove my character for truth and moral deportment.

Saith that he entered the service under Captain Jamison in York District -- and remained in the service until the Battle of the hanging Rock & Rocky Mount, thinks it was four months -- I again joined Captain Jamison & was out two months or until the battle at Blackstock's -- I again after the Battle at Blackstock's I enlisted for ten months or during the War and during my ten months enlistment I was orderly Sergeant -- but did not serve but the 10 months at this Tour -- I was again out in the service but cannot recollect how long I was out at this time = This deponent further states that he here with produces affidavits of Sundry Persons that he served repeated Tours of duty.



district aforesaid and makes oath that he was personally acquainted with James Tracey of Union District South Carolina during the war of the revolution and knew James Tracey to belonged to the State troops of South Carolina under Captain Jacob Barnet, and Colonel Wade Hampton. The soldiers belonging to said State troops were enlisted for the term of 10 months and the said James Tracey served faithfully during that time and that James Tracey enlisted in the State troops about the last of April or first of May 1781. He saw also the said James Tracey frequently before the above date in the militia Service particularly at the Battle of Blackstock's -- that he the said Jacob Black and James Tracey were soldiers under the same Captain viz. Captain James Jamieson of the Militia. The Battle of Blackstock's in the year 1780 in the summer. He also knew the said James Tracy to be a good Soldier and warm friend to the cause of his Country. 

[p 8: On October 16, 1846 in Union District South Carolina, Greenberry Tracy made application under the 1838 and subsequent acts stating that he is the son and one of the heirs of Agnes Tracy widow of James Tracy who was a private and Sergeant in the revolution having served in the South Carolina militia; that his mother was pensioned at the rate of \$53.33 per annum; that his parents were married in 1782; that his father died December 30th, 1839 and his mother died

August 9th, 1844; that the only surviving children at the time of the death of his mother were William Nelson Tracy (who resides in Alabama), James Tracy (who resides in Mississippi) and this deponent Greenberry Tracy (who resides in Union District South Carolina); and a daughter Jane Nelson Tracy married to W. Hollingsworth, both deceased survived only by Elizabeth Hollingsworth now the wife of James Sanford of Union District South Carolina.

[p 21: on December the 2nd, 1846 in Union District South Carolina, Greenberry Tracy made oath that his mother Agnes Tracy died at his house on the 9th day of August 1844; that she was not attended by any physician in her final illness and had been confined to his house during the last 2 months of her life.]

[Veteran was pensioned at the rate of \$53.33 per annum commencing March 4th, 1831, for service for 16 months in the South Carolina service. His widow was initially pensioned at the rate of \$53.33, increased to \$62.66 per annum commencing December 30, 1939, based on establishing his service as an orderly Sergeant for a portion of his time in service.]

The Petition of James Tracey

Respectfully sheweth that during the late war he served as a sergeant in the company commanded by Capt. Jacob Martin (who is since dead) in the Regiment Commanded by Col. Wade Hampton and was to serve for ten months and was to have received therefore the sum of ten dollars per month, for which he has not as yet received any compensation ~ Your petitioner's necessities are and have been such that he should long ago have made this application but such is for want of information that until lately he was not aware when to make his application nor is he now prepared to produce the necessary certificates (his Capt. being dead) and to his great disappointment finds that after coming a considerable distance Gen. Hampton (from whom he could have procured them) has gone to the westward; your petitioner however herewith tenders his affidavit as to the above facts and humbly hopes that it may be considered as satisfactory evidence of the justice of his claim ~ Your petitioner further states that he is now considerably advanced in years and has a family consisting of a wife and a number of small children without any means of support other than his own personal labor ~ Your petitioner therefore humbly prays your honorable body to take his care into consideration and grant such relief as to the law that shall appertain ~ and your petitioner will pray.

Hampton but to his great disappointment finds that he is gone to the Westward; but confiding in the justice and liberality of your Honorable body he herewith presents his affidavit stating the above facts, & humbly hopes that it may be considered as satisfactory evidence of the justice of the claim ~ Your petitioner being extremely ignorant was not aware when he ought to have applied for the payment of this demand until very lately ~ Your petitioner further states that he is now considerably advanced in years and has a family consisting of a wife and a number of small children without any other means of support than his own personal labor.

Your petitioner thus prays your honorable body to take his care into consideration and grant such relief as to justice shall appertain and your petitioner will pray.

That early in the Revolutionary War he joined the armies of his native country as a volunteer and remained therein under the command of Captains Kilpatrick [sic Kirkpatrick]⁵, Jamison and Montgomery until General Hampton ten month men were raised, when he enlisted under Captain Jacob Barnett in Col. Hampton's regiment where he remained until the expiration of his time ~ That not being conscious of the importance of a discharge at the termination of his service and living at a great distance from the residence of my commanding officer he never attained one.

Your petitioner further shewith unto your honorable body that he was in the battles of Rocky Mount, Hanging Rock and Eutaw ~ That he is far advanced in the winter of life, in extremely indigent circumstances, without any one to assist him in acquiring a support ~ That heretofore he had scorned to ask his country for compensation for his service as he fought her battles with different views than those of gain, but through penury and from information of the generous conduct of the legislature to men in similar circumstances, he is now induced to pray your honorable body to place him on the pension rolls of this state and should you think proper to do so he humbly suggests that at the last session of the Legislature he is informed his claims passed the Senate, but for want of vouchers they rejected in the house of representatives, on which account he humbly prays your honorable body to consider the propriety of doing so with a pension from the last year.
