[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]



Motte,¹ and made oath that he is the only son of Major Charles Motte who fell at the lines of Savannah in our Revolutionary War in the year 1779 and that neither himself nor any other of his Father's heirs or Representatives have ever obtained a Land Warrant in right of his said Father's Services.

I John Hart² of the State & District aforesaid depose, that I was a Captain in the 2nd South Carolina Continental Regiment; that Charles Motte was a Major in the same Regiment when the French & American Troops assailed the lines before Savannah in the Revolutionary War.³ That, from my infancy, I was acquainted with the whole of the Motte family: That, I knew of sd applicant for a military Warrant (W. S. Motte) when an infant. Have seen him at his father's house & firmly believe he is the only [indecipherable word] of his father's family & whose father the Major I saw been killed in assailing the line before Savannah.

Before me personally appeared Peter Horry and made oath that [indecipherable word] by grade in the general line agreeable to the laws of Congress & established was promoted from the majority of the 2nd South Carolina Continental Regiment to the Lieutenant Colonelcy [sic, Colonelcy] in the 5th Regiment of the aforesaid State, that by the order of General Lincoln he was attached to the Light Corps commanded by Colonel Laurence [John Laurens] that when the attack was made on the lines of Savannah this Corps was broken shortly after the attack commenced, that this Deponent in endeavoring to rally the Corps which was broken came to the spot where Major Charles Motte lay slain before the Abettes [sic, abattis], that he served in the same Regiment with Major Motte as Captains previous to his promotion, this Deponent further swears he has no reason to doubt but believes William S. Motte the applicant for a Military Warrant to be the son of Major Charles Motte above mentioned.
