[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indcipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of North Carolina Orange County } Court of Pleas & Quarter Sessions February Term 1845

On this the 28th day of February 1845, personally appeared in open Court before the Court of pleas and Quarter Sessions for said County, now sitting, John Lewis a resident of said County, aged 54 years, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed July 7th, 1838.

This Declarant in behalf of himself and the other heirs of his deceased mother Sarah Lewis, doth on his oath make the following Declaration to wit:

1. This Declarant has reason to believe and does believe that in the war of the Revolution his Deceased father John Lewis, did as a private Soldier serve the United States a tour of three months duty in the militia, Captain Bethel's [William Bethel's] Company, and under General Caswell [Richard Caswell]. In this tour his father was in the service a period of three months and at the expiration of this tour was duly discharged by his Captain Bethel and returned home: which said discharge is hereto attached and which this Declarant believes to be a true & genuine discharge as it purports to be, and which discharge was recently found among some of his deceased father's old papers.
2. The said John Lewis Declarant as aforesaid, further setteth forth upon his said oath, that he has reason to believe and does believe that in the year before the Close of the said war of the Revolution his deceased father John Lewis aforesaid, was drafted to serve the United States a Continental draft of 12 months, and did serve [paper torn] of said period -- the Company to which said Lewis was attached was Commanded by Captain Mills [James Mills, 1<sup>st</sup> NC Regt.], and was in the said tour in the South under General Greene [Nathanael Greene]. At the expiration of said Continental draft, this declarant believes his father was duly discharged and returned home, but that his discharge from the Continental draft is lost or mislaid, so that this Declarant cannot find it. The said Declarant would further state, that his father's papers are nearly all destroyed, there having been but little or no care taken of them.

That in both of the foregoing tours this Declarant has reason to believe that the said John Lewis was in legally organized Corps and called into service by competent Authority.

The said John Lewis further declares, that he has reason to believe and does believe that his parents, the aforesaid John and Sarah Lewis were married sometime in the year 1783.

That they have no regular "family Record." This Declarant has obtained a memorandum of the births of the oldest of the Children, which said memorandum is hereto attached and is as

follows, viz.

"Eley Lewis was born October 26th 1784" and which memorandum this Declarant has reason to believe and does believe is true.

The said John Lewis further sets forth, that he has obtained the affidavit of Phamy Pearson of Rockingham County who was present and witnessed the solemnization of the rites of marriage between his parents, said affiant sets forth that said marriage was solemnized in the year 1783, that the marriage was solemnized at the residence of James Nichols in the County of Rockingham in the State aforesaid.

That his father the aforesaid John Lewis, did die in the year of 1802 leaving the aforesaid Sarah his widow, who did not afterwards marry but remained his widow until her death.

That said Sarah Lewis did die on the 18th day of November 1842.

And that said Sarah Lewis left surviving her the 7 following Children to wit Olley, who intermarried with David Brinsfield, James H. Lewis, and Mary who intermarried with Jeremiah Pritchett, John Lewis, Westly<sup>1</sup> Lewis, Andrew Lewis and Elizabeth who intermarried with Joseph Pritchett, all of Lawful age.

That the said Sarah was not married to the aforesaid John Lewis prior to his leaving the service, but the marriage took place previous to the first January 1794 viz. at the time above stated parenthesis 1783).

I William Hill, Secretary of State, in and for the State of North Carolina, do hereby certify, that it appears from the muster-rolls of the Continental line of this State, in the Revolutionary War, that John Lewis a private soldier in Captain Montford's [James Montford's]

Company of the 10th Regiment, entered the service on the 20th day of July 1778 for the term of 9 months and that he again enlisted on the 13th of January 1782 in Captain Mills's [James Mills'] Company in the said 10th Regiment for the term of 12 months, and that nothing more is said of him on said rolls.
