[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Tennessee Anderson County: On this 13th day of July 1818 before me the subscriber one of the Judges of the Quorum Court of said County and presiding Judge or Justice of said Court personally appeared Thomas Parsons aged sixty two years resident in the County of Anderson aforesaid who being by me duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War" That he the said Thomas Parsons enlisted in the year 1777 in the state of Virginia in the company commanded by Captain George Rice of the 11th Virginia Regiment commanded by Colonel Daniel Morgan for three years that he continued to serve the United States against the common enemy until the expiration of said three years and was then discharged in the State of New Jersey that he was in the battle at Iron Hill [September 3, 1777; a/k/a Battle of Cooch's Bridge, DE] at the Battle of Brandywine [September 11, 1777] at the Battle at Germantown [October 4, 1777] at the battle of Monmouth [June 28, 1778] at Stony Point [July 16, 1779] and several skirmishes that he has lost his discharge, that he is in reduced circumstances and needs the assistance of his Country for support that he has no other evidence now in his power of his said services except the affidavit hereto annexed that he never has been a pensioner and does hereby relinquish all claim to a former pensions provided for.

State of Tennessee Anderson County: On this 13th day of July 1818 also appeared Edward Wyatt a citizen of said County of Anderson aforesaid and made oath that he was a neighbor of Thomas Parsons who signed the preceding declaration when he enlisted in the Revolutionary War that he is satisfied said Thomas Parsons did serve the United States as stated by him he is not certain as to the time he entered the service but knows he entered for 3 years and served out his time and knows when he returned to his neighborhood and is entirely satisfied that the statement above made by him is just and true and that said Thomas Parsons is in reduced circumstances & needs the assistance of his Country for support.

Schedule

State of Tennessee Anderson County: SS July Sessions 1820

On this 10th day of July 1820, personally appeared in open court, being a court of record, (having the power of fine and imprisonment and also having been made a court of record by the laws of the said State) for the said County, Thomas Parsons aged sixty four years, a resident of the County of Anderson aforesaid, who, being duly sworn, according to law, doth on his oath declare that he served in the revolutionary war as follows: That he served the United [States] 3 years in the Revolutionary War – That he enlisted with Captain George Rice in the 11th Virginia Regiment of Riflemen commanded by Colonel Daniel Morgan – that his original declaration bears date the 30th of July 1818. This [sic, That?] his pension Certificate is of No. 5307

And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled “an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war” passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

50 acres of land of the value of \$75.

That he has a scanty allowance of household furniture belonging to his daughters – That he has a wife aged 73 years and unable to labor. That he has 2 children living with him to wit Pheby aged 28 years and Rebeckah aged 24 years both single and able to labor. That from age and infirmity he is unable to labor himself –

[Facts in file: Veteran died February 15, 1826; his widow died 1838; in 1852 the veteran's grandson, Thomas Hale [Halle or Hall?], was living in Delray, Anderson County, Tennessee and stated that his mother was still living but did not give her name.



[Veteran was pensioned at the rate of \$8 per month commencing July 13, 1818, for service as a private in the Virginia Continental line.]
