[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

The committee to whom the petition of Robert McElwrath was Referred:

Report

That they have examined the account & Vouchers of the Petitioner, and recommend that he be Allowed at the rate of Four Thousand pounds, undepreciated old Currency a year, from the 11th of September 77 [1777] to the 12th of May 1780 when he was made a Prisoner. Your Committee finding, that at the time he was made State armorer, it was not the Intention of the Executive, that his Salary should be Subject to Depreciation & that during the time above specified, he actually Employed at his own expense, Three White Men, & Three Negroes besides his own labour, in Repairing, & keeping in order the public Arms.

Your Committee also recommend, that he be allowed at the rate of £2000 a year, during the time he was Prisoner – and that from the 17th of May 1781 to 1782 (during which time your Committee find that the Petitioner was again employed as State Armorer, and was of Remarkable Service, to the State Troops, & Militia of this State) he be allowed his old Salary of £4000 Old Currency a Year, and that a Deduction be made in his Accounts for the value of the Money Received by him from the State.

That they have examined the Account and Vouchers of the said Petitioner, and recommend that he be allowed at the rate of Four thousand pounds undepreciated Old Currency a Year from the 11th of September 1777 to the 12th of May 1780² when he was made a prisoner, – Your Committee finding that during the time above Specified he actually employed at his own expense three White men and three Negroes besides his own labour in repairing & keeping in order the Public Arms.

Your Committee also recommend that he be allowed at the rate of £2000 Old Currency a year during the time he was a prisoner and that from the 17th May 1781 to May 1782 (during which time your Committee find the petitioner was again employed as State Armorer, and was of remarkable Service to the State Troops & Militia of this State) he be allowed his Whole Salary of £4000 Old Currency a year And that a deduction be made in his accounts for the Value of the Money received by him from the State and that he be allowed Interest on the Balance –
