[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

At a court of Common Pleas begun to be holden at Spartanburg Court house in and for the district of Spartanburg on the 2nd Monday after the 4th Monday in October being the 5th day of November in the year of our Lord 1827 Present his Honor Judge Gantt.

State of South Carolina Spartanburg District

On this the fifth day of November 1827 personally appeared in open Court being a Court of Record for the district of Spartanburg having unlimited power and Jurisdiction in all cases at issue, Archibald McCrevy [sic] a resident of said district aged eighty two years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the acts of Congress of 18th March 1818, and the first of May 1820 that he the said Archibald McCrevy enlisted for the term of three years sometime in the forepart of the year 1776 in the State of North Carolina in the company commanded by Capt. John Nelson in the 4th Regiment commanded by Col. Poke [sic, Thomas Polk] or Pogue in the line of the State of North Carolina on the Continental establishment that he continued to serve in the said corps until sometime in the first of the year 1779 when he was honorably discharged from the service (having completed his term of three years in the 4th Regiment in the State of North Carolina that he hereby relinquishes every claim whatever to a Pension except the present that his name is not on the roll of the State except the State of North Carolina and that the following are his reasons for not making earlier application for a Pension to wit First because I was unwilling to the Chargeable to my Country -- 2nd not having the prospect of offering the testimony I now offer. 3rdly I did offer a Declaration¹ before his Honor Judge Richardson which was returned for some small informality and lack of evidence. And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or otherwise disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed --

And more over I do Solemnly Swear that since the 18th day of March 1818, that no change has taken place in my property -- I am a carpenter by occupation but so worn down with age that I am unable to obtain a support by my labor. I have no family except my wife Jane McCrevy aged near sixty who is more infirm than is common of her age. Sworn to & subscribed in open Court saith November 1827

State of Tennessee Humphreys County} Came personally before me and duly made oath the following deponents (to wit) Breton George[,]² David Passmore³ & David Ivy⁴ and depose that they were well acquainted with Archibald Macquarie in the Revolutionary war and know that he Enlisted into the Service of the United States on the Continental Establishment North Carolina line 4th Regiment Captain Nelson's company Under the command of Colonel Poke [sic] in the forepart of the year 1776 and that he faithfully Served his term of 3 years when he was honorably discharged Early in 1779. Sworn and subscribed this 1st day of March 1828





[p 12: On April 3, 1855 in Spartanburg District South Carolina Samuel McCravy [sic], 56, a resident of said District file for the arrears of pension due to his mother under the 1838 act from March 4, 1854 (the date of her last pension payment) up to June 17, 1854 when she died. He states that his mother left no estate but some articles of little value. That her surviving children were Mary Woodard, Sarah Pruitt, Samuel McCravy, Massey Striplin, Chistena Holms & Jane Harrison. He signed the document with his mark.]

On this 29th day of May 1850 personally appeared before me Sam K. Sumner one of the acting Magistrates in and for said District Mrs. Mary Smith who being first duly sworn according to law doth on her oath make the following affidavit to wit

That she is personally acquainted with Jane McCrery widow of Archibald McCrery & was before she married the said Archibald. That she well knows that they were married prior to the birth of her Brother Robert Morrow and that her brother Robert was born in November 1793 as appears of record (the original Family record now in the Pension office sent there by her mother Mrs. Morrow,⁶ She Knows that the aforesaid Marriage took place prior to the birth of her brother Robert from the following facts to wit Sometime in the early part of the fall of 1793 he the deponent's father went to market and she the deponent's Mother got the said Jane to come & stay with her while he the said deponent's Father was gone to Market & [undeciphered words] that She Jane came to that House on Sunday & on Monday Jane's Parents came & took her Home and in a Short time after they took her Home they Jane & Archibald as she the deponent understood ran off & got married. She further knows that her Mother was then pregnant with her brother Robert which Jane McCrery was there - & sometime after she heard that Jane & Archibald was married her brother was born. That she does well recollect that the aforesaid marriage took place at the time above stated and does now solemnly swear that she Jane was married with said Archibald McCrery before the Birth of her Brother Robert.

[p 85: Jennett Morrow gave testimony on April 3, 1849 in Spartanburg District South Carolina stating that she well knew Jane McCrery widow of Archibald McCrery; that they were married sometime in the fall of 1793 which she remembers because she was pregnant with her sixth child Robert who according to the family record was born on 17th day of November 1793. She signed her affidavit with her mark.]

[Facts in file: Veteran married Jane Cathcart on September 16 or 17, 1794; she executed an application March 23, 1846 while living in Spartanburg District, SC, aged 77. She died June 17, 1854 survived by the following children: Nancy Woodward or Woodard, born July 18, 1794; Sarah Pruyette or Pruit; Massey Striplin; Christena or Crissey Holms or Homes; Jane, wife of Andrew Harrison; John and Samuel who was a resident of Spartanburg District aged 56 in 1855. There is reference in the file to a family record showing the marriage of the veteran to Jane Cathcart, but I didn't find it in this file. In such a large file, it is possible I missed it or that it is the record referred on p 24 which is too faint to discern in the documents posted online.]

[Veteran was pensioned at the rate of \$8 per month commencing August 12, 1828 for service as a private for three years in the North Carolina Continental line. His widow was pensioned in a like amount commencing July 1, 1848 and ending June 17th, 1854.]
